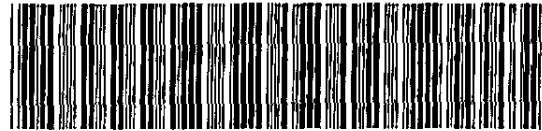



ARTICLES OF INCORPORATION

OF

G-LICIOUS ENTERPRISES, INC.

Article I
Name

The name of this Corporation is G-LICIOUS ENTERPRISES, INC.

Article II
Duration

The Corporation shall have perpetual existence.

Article III
Purpose and Principal Place of Business

Purpose. This Corporation is organized for the purposes of transacting any or all lawful business.

Principal Place of Business. The initial street address of the principal place of business of the Corporation is 15107 Kestrel Rise Drive, Lithia, Florida 33547.

Article IV
Capital Stock
