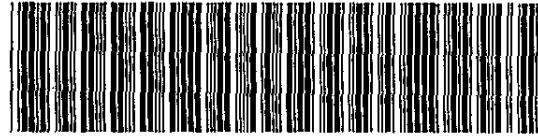

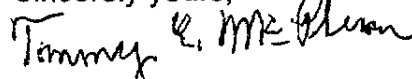

ARTICLE ONE

The name of the corporation is CUSTOM EXTERIORS OF PENSACOLA, INC.

ARTICLE TWO

The duration of the corporation is perpetual.

ARTICLE THREE

The general purposes for which the corporation is organized are:

1. The application of stucco and other exterior siding.
2. To transact in any other lawful business for which corporations may be incorporated under the Florida General Corporation Act.
