**ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS**

The name of this corporation is SALRAL, Inc. and its principal place of business shall be located at 10159 Noreiga Lane, Pensacola Fl 32514.

**ARTICLE II - DURATION**

**ARTICLE X - INDEMNIFICATION**

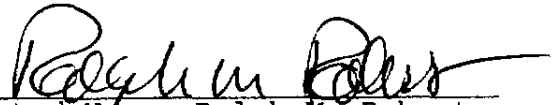

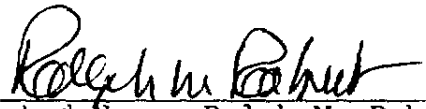
