## ARTICLES OF INCORPORATION

OF

## AOC 9, Inc.

- ARTICLE I. The name of this corporation is AOC 9, Inc., operating at 2300 Corporate Blvd., NW, Suite 232, Boca Raton, FL 33431.
- **ARTICLE II.** This corporation shall have perpetual existence, unless sooner dissolved according to law.
