The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE I: NAME**

The name of the Corporation is Doral's Restaurant, Inc. Principal place of business is 7780 N.W. 44<sup>th</sup> Street, Sunrise, Florida 33351.

**ARTICLE II: DURATION**
