OF

ARTICLE I - NAME

The name of this Corporation is Marty's Dents & Scratches on the Go, Inc.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on January 12, 2005.

ARTICLE III - PURPOSE

This Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - CAPITAL STOCK

This Corporation is authorized to issue One Thousand (1,000) shares of \$1.00 par value common stock.

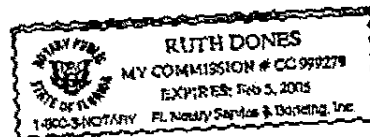
