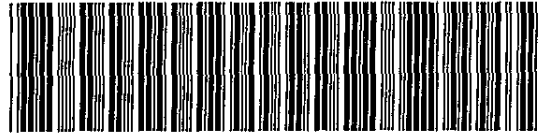

AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF

Pursuant to the provisions of Section 607.1007 of the Florida Business Corporation Act, the undersigned corporation, originally incorporated under the name of Haynes of Bay County, Inc. on the 12th day of January, 2005, pursuant to a Resolution duly adopted by its Board of Directors hereby adopts the following Amended and Restated Articles of Incorporation:

FIRST:

The name of the corporation is HAYNES OF BAY COUNTY, P.A.

SEVENTH:


These Amended and Restated Articles of Incorporation are duly adopted by the incorporator's Board of Directors without shareholder action and that shareholder action was not required.
