**ARTICLES OF INCORPORATION
OF
ADAM COLEMAN, INC.**

The undersigned, as Incorporator of Adam Coleman, Inc. ("Corporation"), a for-profit corporation organized for the purposes of home inspection, under the provisions of Chapter 607, Florida Statutes, adopts the following Articles of Incorporation:

**ARTICLE I.
NAME**

The name of the Corporation is Adam Coleman, Inc.

**ARTICLE II.
PRINCIPAL OFFICE**

The principal office and place of business of the Corporation shall be 3232 SE County Road 21-B, Melrose, Florida 32666.

**ARTICLE III.
PURPOSE**

The Corporation is organized and shall be operated for the purposes of providing home inspection services to buyers and sellers of real estate.

**ARTICLE IV.
POWERS**

The Corporation shall have all the powers and authorities as are now or may hereafter be granted to Corporations not-for-profit under the laws of the State of Florida, including, but not limited to, the power to purchase, own, sell, and otherwise deal with real and personal property, to borrow and lend money, to make contracts with others for goods and services, to elect officers and appoint agents, to carry on its operations through its officers, employees and agents within or without the State of Florida.

This Corporation shall have perpetual existence unless it shall be dissolved according to the laws of the State of Florida.

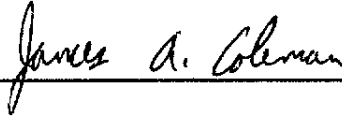
