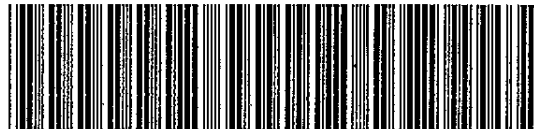





ARTICLES OF INCORPORATION

The undersigned, acting as the incorporator of a corporation under the Florida Corporation Act, adopts the following articles of corporation for such corporation.


