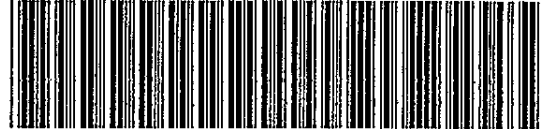

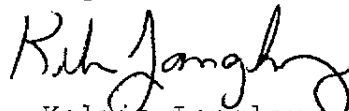

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I. NAME.

The name of the corporation shall be Langley Well Drilling, Inc.

ARTICLE II. PRINCIPAL OFFICE & MAILING ADDRESS.

The principal place of business of this corporation shall be: 1000 S. Line Road, Lecanto, Florida 34461. The mailing address of this corporation shall be: P.O. Box 295, Lecanto, Florida 34460.

ARTICLE III. PURPOSE.

This corporation was organized to conduct all business deemed proper and necessary for well drilling and to conduct all other legal business.

ARTICLE IV. CAPITAL STOCK.

The number of shares of stock that this corporation is authorized to have outstanding at any one time is 500 shares, each share having a par value of \$1.00.

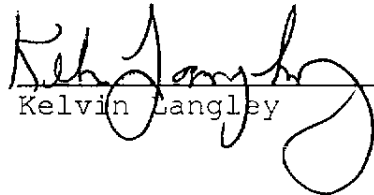

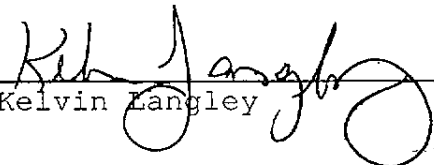
