

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I. NAME.

The name of the corporation shall be Wilbur Langley Well & Pumps, Inc.

ARTICLE II. PRINCIPAL OFFICE & MAILING ADDRESS.




