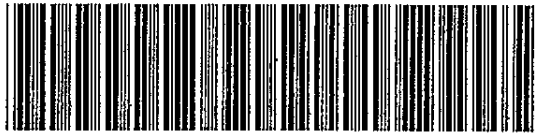

The undersigned, acting as incorporator of a Florida corporation under the Professional Service Corporation and Limited Liability Company Act, Chapter 621 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME AND BUSINESS ADDRESS

The name of the Corporation is Ileana M. Salort-Morales, P.A. Its mailing address and principal place of business is 4881 NW 107th Court, Miami, FL 33178.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

ARTICLE IV - CAPITAL STOCK
