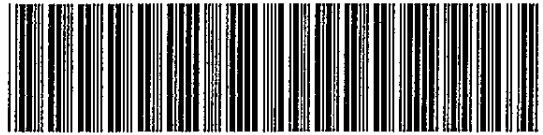

The undersigned, JANET BOSCO, does hereby make, subscribe, acknowledge and files these Articles of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of this corporation shall be FJMC CORPORATION.

ARTICLE II

NATURE OF BUSINESS

The corporation is organized for the purpose of owning and operating a hair and nail salon and any other legal purposes, with its principal place of business at 1322 Seven Springs Boulevard, Trinity, FL 34655, and mailing address shall be the same.

ARTICLE III

CAPITAL STOCK

The capital stock of this corporation shall consist of One Hundred (100) shares of common stock with par value of One Dollar (\$1.00).

ARTICLE VII

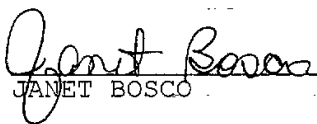

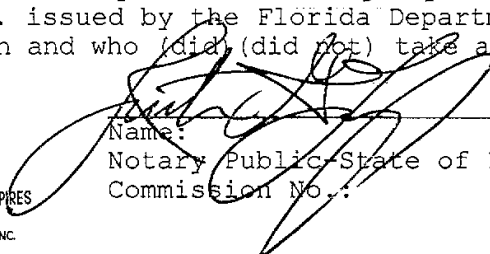
