# ARTICLES OF INCORPORATON

The undersigned, for the purpose of forming a corporation under the Florida Personal Service Corporation Act, Chapter 621, Florida Statutes, do hereby adopt the following articles of incorporation.

### ARTICLE ONE

The name of the corporation is REHABILITATION AT SOBRENITY, INC.

The business address of REHABILITATION AT SOBRENITY, INC. is 735 N.E. 15<sup>th</sup> Avenue, Fort Lauderdale, Florida 33304.

### ARTICLE TWO

The duration of the corporation is perpetual.

### ARTICLE THREE

The purposes for which the corporation is organized are:

- 1. To transact any lawful business for which corporations may be incorporated under the Florida Personal Service Corporation Act, Specifically:
- a. Rehabilitation Center
- 2. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

# **ARTICLE FOUR**

The aggregate number of shares which the corporation is authorized to issue is 7500. Such shares shall be of a single class, and shall have a par value of One Dollar (\$1.00) per share.

### ARTICLE SEVEN

No contract or other transaction between the corporation and one or more of its directors or any other corporation, firm, association, entity in which one of more of its directors of officers are financially interested, shall be either void or voidable because of such relationship or interest because such director or directors are present at the meeting of the Board of Directors or a committee thereof which authorizes, approves, or ratifies such contract or transaction or because his or their votes are counted for such purposes, if:

- (a) The fact of such relationship or interest is disclosed or known to the board of director or committee which authorizes, approves, or ratifies the contract or transaction by a vote or consent sufficient for the purposes without counting the votes or consents of such interested directors; or
- (b) The fact of such relationship or interest is disclosed and known to the stockholders entitled to vote and they authorize, approve, or ratify such contract or transaction by vote or written consent; or
- (c) The contract or transaction is fair and reasonable as to the corporation at the time it is authorized by the board, a committee or the stockholders.

### **ARTICLE EIGHT**

The power to amend, adopt and/or repeal the By-Laws for the corporation shall be reserved to the shareholders.

### **ARTICLE NINE**

Special meetings of stockholders may be called at any time by the President or holders of ten percent (10%) of all outstanding shares.
