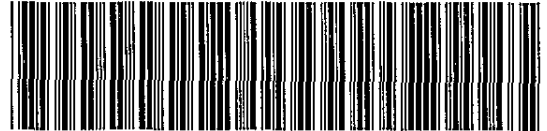

The name of this corporation is D & H FOOD AND FUEL INC.
