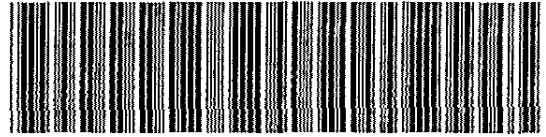


ARTICLE XI


