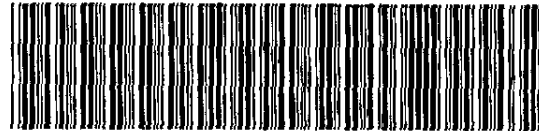



**(In compliance with Chapter 607 and/or Chapter 621, F.S.)**

**ARTICLE I**

**Name:** The name of this corporation is Forrester Builders, Inc.

**ARTICLE II**

**State of Incorporation:** This corporation is hereby formed under the laws of the State of Florida, in compliance with Chapter 607 and/or Chapter 621, F.S.


**Other Provisions:** The effective date for these Articles of Incorporation to become effective is the date on which they are accepted by the Florida Secretary of State.
