

ARTICLE I

The name of this corporation shall be **CYPRESS VILLAS APARTMENTS III, CORP.**

ARTICLE II

PRINCIPAL OFFICE

The principal office of this corporation shall be at: 2217 SE 12<sup>th</sup> Street, Pompano Beach, FL 33062.

ARTICLE III

DURATION

The corporation shall have perpetual existence unless sooner dissolved according to law.

ARTICLE IV

PURPOSE


