**ARTICLES OF INCORPORATION
OF
DANIEL SEPULVEDA, INC.**

The undersigned, acting as the Incorporator of a corporation (the "Corporation") under the laws of the State of Florida as contained in the "Florida Business Corporation Act", Chapter 607 of the Florida Statutes, as amended, does hereby adopt the following Articles of Incorporation for the Corporation:

1. The name of the Corporation is DANIEL SEPULVEDA, INC.
2. The street and mailing address of the Corporation is 6701 Mallards Cove Road, Apt. 9-H, Jupiter, FL 33458.
3. The Corporation shall have perpetual existence.
4. The aggregate number of shares which the Corporation shall have authority to issue is One Thousand (1,000) shares of common stock having a par value of One Dollar (\$1.00), all of one class.


