**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
WORKPLACE EAST INVESTORS, INC.**

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is Workplace East Investors, Inc. (the "Corporation").
2. The following amendment to the Articles of Incorporation was adopted by the Sole Voting Shareholder (the number of votes cast being sufficient for approval) and the Sole Director of the Corporation by the Written Consent of the Sole Director and Sole Voting Shareholder in Lieu of a Special Meeting dated March 2, 2005, in the manner prescribed by Sections 607.1003 and 607.1006 of the Florida Statutes:

"ARTICLE I - NAME"

3. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same.
