ARTICLE XDirector Compensation



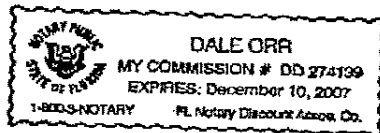


