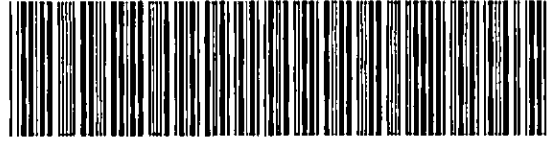

**Articles of Dissolution**

Pursuant to Fla. Stat §607.1401, this Florida profit corporation submits the following Articles of Dissolution:

**Article 1**  
**Corporate Name**

The name of the corporation as currently filed with the Florida Department of State is A B C Plumbing & Gas Services, Inc., Document No.: P05000008300.

**Article 2**  
**Incorporation Date**

Articles of Incorporation were filed on January 18, 2005.

**Article 3**  
**Adoption of Dissolution**

Pursuant to Fla. Stat. §607.1402, §607.0704 and a majority vote of the corporation's shareholders which is sufficient for approval, the plan of dissolution was authorized on October 4, 2022.

**Article 4**  
**Debts**

Pursuant to Fla. Stat. §607.1406 (10), the corporation or successor entity shall pay or make reasonable provision to pay all claims and obligations, including all contingent, conditional, or unmatured claims known to the corporation or such successor entity but for which the identity of the claimant is unknown. Such claims shall be paid in full, and any such provisions for payment

made shall be made in full if there are sufficient funds. If there are insufficient funds, such claims and obligations shall be paid or provided for according to their priority and, among claims of equal priority, ratable to the extent of funds legally available therefor.

**Article 5**  
**Shareholder Distributions**

Pursuant to Fla. Stat. §604.1406 (10), remaining funds, if any, shall be distributed to the shareholders of the dissolved corporation after the corporation or successor entity has paid or make reasonable provision to pay in full all claims and obligations, including all contingent, conditional, or unmatured claims known to the corporation or such successor entity but for which the identity of the claimant is unknown.

**Article 6**  
**Effective Date**

These Articles of Dissolution shall be October 4, 2022, or the filing date of these Articles of Dissolution, whichever is later.
