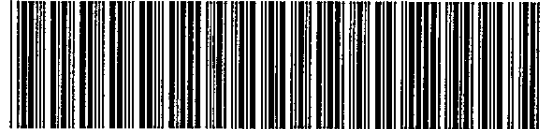

OF

ARTICLE I- NAME

The name of the corporation is Big E'S Cleaning Services, Inc

ARTICLE II- PRINCIPLE OFFICE

The principle place of business and mailing address of this corporation shall be 1044

ARTICLE III-PURPOSE

This corporation shall have the power to engage in the following: Provide

more offices and/or bid on commercial and residential cleaning contracts, in the State of
