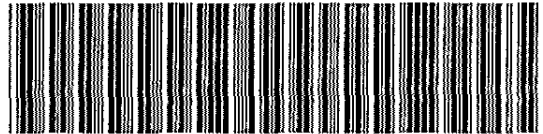

ARTICLE I




