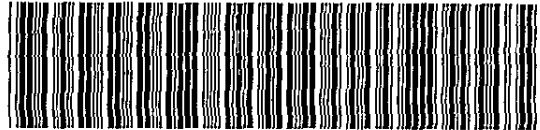

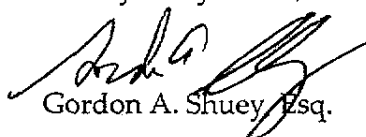

ARTICLES OF INCORPORATION  
OF  
JOHN ORLANDO INCORPORATED

The undersigned, for purposes of forming a corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I  
NAME

The name of the corporation shall be John Orlando Incorporated.

ARTICLE II  
DURATION

The term of existence of the corporation is perpetual.

ARTICLE III  
PURPOSE

The purpose of the corporation is:

To engage in and to transact any and all lawful business for which a corporation may be incorporated under the laws of the State of Florida.

ARTICLE IV  
CAPITAL STOCK

The aggregate number of shares which the corporation has authority to issue is One thousand (1,000) shares, all of which shall be common shares with a par value of one dollar (\$1.00).

ARTICLE V  
REGISTERED OFFICE AND REGISTERED AGENT

The street address of the initial registered office of the corporation is 5311 Nadine Street, Orlando, Florida 32807. The name of the initial registered agent at such address is John Orlando.

ARTICLE VI  
PRINCIPAL PLACE OF BUSINESS

The initial principal place of business of the corporation shall be 5311 Nadine Street, Orlando, Florida 32807 until otherwise designated by the corporation.

ARTICLE VII  
DIRECTORS

The Board of Directors of the corporation shall consist of at least one director and no more than five directors. The initial Board of Directors shall consist of one director, whose name and address is set forth below:

corporation, thereafter, the shareholders shall have exclusive authority to amend the bylaws of the corporation by a majority vote of all outstanding shares.

The corporation shall commence operations on January 1, 2005.

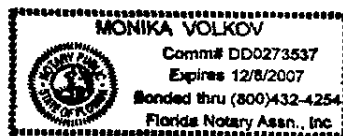

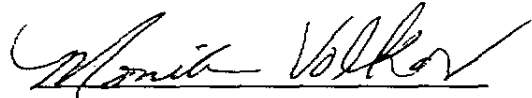
