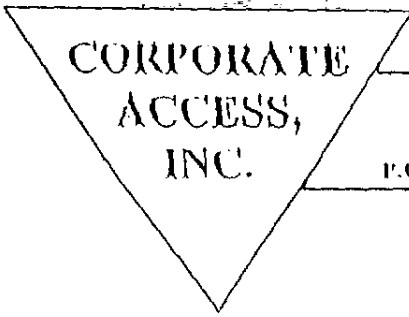

**ARTICLE I.**
