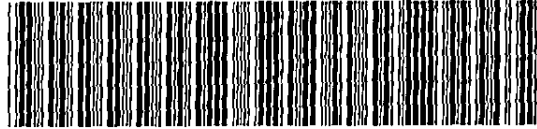

ARTICLES OF INCORPORATION

OF

COMPLETE CONSTRUCTION OF EAST COAST, INC.

ARTICLE I - NAME AND PRINCIPAL LOCATION

The name of this corporation is "COMPLETE CONSTRUCTION OF EAST COAST, INC." The principal location of the corporation is 235 S. Caroline Street, Daytona Beach, Florida 32117.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of land clearing and any other purpose and engaging in any act, duties or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue FIVE HUNDRED (500) shares of common class, at One Dollar (\$1.00) par value.

ARTICLE V - CAPITAL STRUCTURE: Subchapter S Corporation

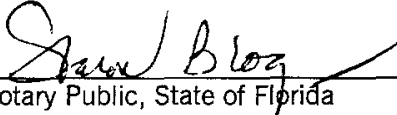
