**ARTICLES OF INCORPORATION
OF
WEST GROUP DIVERSIFIED SERVICES, INC.**

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is WEST GROUP DIVERSIFIED SERVICES, INC., and the principal address and principal place of business is P. O. BOX 530005, GULFPORT, FLORIDA 33747.

ARTICLE II - REGISTERED OFFICE AND AGENT
