Joy's broken wrist was very difficult to treat because of severe osteoporosis, and even after elaborate pinning by a skilled surgeon it has required skilled therapy treatments every other day. However, we are overjoyed this week that she has now been discharged to her own careful massaging and is able to drive again.

During this difficult time, we were blessed with Libby's constant help and our former daughter-in-law, Monique, for the critical early weeks. She just took charge of our life and was wonderful.

John has also had his full 87 years schedule of vital body parts acting up and some, although quite serious, have responded well to the expert medical treatment almost on our doorstep. The approximately three square mile area where we bought into our final retirement home, is zoned accordingly and "hospital-medical" and we now have all the attention was could possibly need. All is built in a park-like environment and, if we need it, Oak Harbor offers full scale living, nursing, recreational and entertainment services. So with their help, twelve pills a day, oxygen masks at night for both of us, my two sticks – one for Joy, elaborate hearing aid and eye glasses, we are still able to enjoy our beautiful garden, now full of colour, and a daily walk around the 8<sup>th</sup> and 9<sup>th</sup> holes of the short golf course winding around our homes.

Some of you to whom this annual message is a continuation of a long tradition of happy communication may respond "What a miserable report" – not so – the alternative would have been "incompetent silence" and instead we can now rejoice in our ability to communicate – strange as it may seem – in a happy and grateful mode. Alas we have to yield completely to our traveling instincts and are now truly "stay at home folks" dreaming about trips we would love to make.

Our only worry is the fear of hurricanes which we hope will spare us this year. What a blessing that would be. On that note, we close this message with our grateful thanks for your friendship and other kindnesses throughout the years. Its quite possible that this message will be our swan song but if we are still able to write next Christmas, we shall try to send a signature cards which will have to cater for one thousand words.

All our love and best wishes come out to you herewith and may you be rewarded with good health and much happiness from John and Joy Steggles.
