**ARTICLES OF INCORPORATION  
OF  
SOUTH FLORIDA CUSTOM AUTO, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

**ARTICLE I  
NAME**

The name of the Corporation ("Corporation") is South Florida Custom Auto, Inc.

**ARTICLE II  
PURPOSE**

The Corporation shall engage in any activity or business permitted under the laws of the United States and of the State of Florida.

**ARTICLE III  
TERM OF EXISTENCE**

The Corporation shall have perpetual existence starting on the date these Articles of Incorporation are filed by the Florida Department of State.

**ARTICLE IV

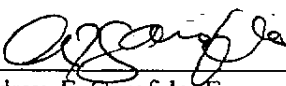

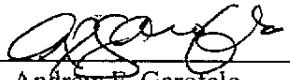
