**ARTICLE I**

The name of the corporation is All City Yellow Cab, Inc. (hereinafter called the "Corporation").

**ARTICLE II**

**ARTICLE III**

The capital stock authorized, per value thereof, and the characteristics of such stock shall be as follows:

**ARTICLE VIII**


This Corporation shall indemnify and shall advance expenses on behalf of its officers and directors to the fullest extent not prohibited by law in existence either now or hereafter.
