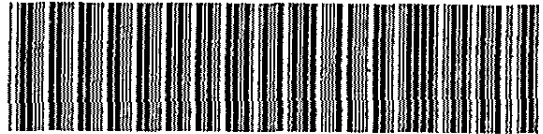

ARTICLES OF INCORPORATION

JON WILLEKE & ASSOCIATES, INC.

The undersigned incorporator, for the purposes of forming a corporation under the laws of the State of Florida, hereby certifies as follows:

Article I

The name of the corporation shall be JON WILLEKE & ASSOCIATES, INC.

Article II

The corporate existence shall begin upon the filing of these Articles with the Department of State of the State of Florida. The duration of the corporation shall be perpetual.

Article III

The corporation is formed for the purpose of engaging in the business of buying and selling equipment, as an agent for others, as well as any and all related or incidental activities. This corporation may also engage in any lawful business for which a corporation may be incorporated under the laws of the State of Florida. This corporation shall have and may exercise any and all powers necessary, convenient or incidental to the carrying out of any business in which it may be engaged.

Article IV

Article VII




