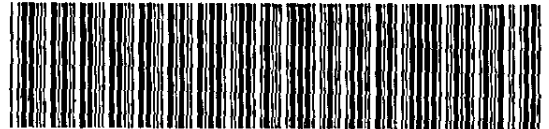

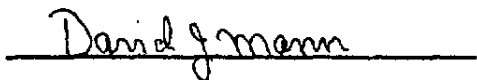

Article I Name

The name of this corporation is Tara L. Priest, Inc.

Article II Duration

This Corporation shall have perpetual existence

Article III Purpose

This corporation is organized for the purpose of transacting any and all lawful business.

Article IV Capital Stock Authorized

Section 1. Authorized Shares

This corporation is authorized to issue 5,000 shares of common stock with a par value of \$1.00 per share, which shall be designated
"Common Shares"

Section 2. Voting Rights

Except as otherwise provided by law, the entire voting power for the election of officers and for all other purposes, shall be vested exclusively in the holders of the outstanding common shares.

Article V Initial Capital
