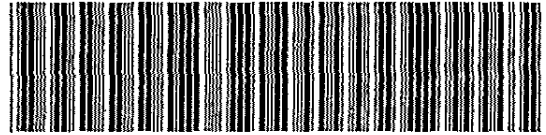

ARTICLES OF INCORPORATION

OF

McCulloch Jet USA, Inc.

ARTICLE ONE

The name of this corporation is McCulloch Jet USA, Inc. and the mailing address of the corporation shall be 6900-29 Daniels Parkway, B 187, Fort Myers, Florida 33912.

ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date these Articles are filed with the Secretary of State.

ARTICLE THREE

The duration of the corporation is perpetual.

ARTICLE FOUR

The general purposes for which the corporation is organized are:
