#### Articles Of Incorporation

We, the undersigned, hereby associate together for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provision of the laws of the state, providing for the information liabilities, rights, privileges and immunities of a corporation for profit.

#### Article I

#### Name, Address and Agent

The name of this corporation shall be: <u>D & D Merchandise</u>, <u>Inc</u>.

(hereinafter referred to as the corporation.) Its registered and principle office shall be located at: <u>24420 South Dixie Highway Miami</u>, <u>FL 33032</u> in the County of Dade. Its Registered Agent shall be <u>Delores Negron Lewin</u>, located at <u>24420 South Dixie</u>

#### Article II

#### Nature of Business

Section I. The general nature of the business and objects and purpose to be transacted, promoted and carried on are to do any and all things hereinafter mentioned, as fully and to the same extent as natural persons might or could do, viz:

- a. To carry on business in the United States or any foreign-country or countries, to buy, self, import, export, lease, sublease, hold, procure, transport, manufacture, acquire and deal generally, both wholesale and retail, in goods and services of all types, both as principal and agent, in any part of the world.
  - b. To enter into, make, perform and carryout contracts of every kind and for the

lawful purpose with any person, firm, association and/or corporation.

- c. To exchange in the currency of foreign countries and the currency of the United States
- d. To issue bonds, debentures, and/or obligations of the company from time to time, for the objects and purposes of the company, and to secure the same by mortgage pledge, deed or \_\_\_\_\_\_ trust, or otherwise.
- e. To purchase, hold and reissue the shares of its capital stock; and to subscribe to purchase, or otherwise acquire, or to guarantee, or to become surety in respect to the stock, bonds or other securities and obligations of the company and other companies.
- f. To do all such acts or things as they are incident or conductive to the premises, and to do all and everything necessry, suitable, convenient, or the proper for the accomplishement of any of the purposes of attainment of any of the objectives herein enumerated or incidental to the powers herein named, or which shall at any time appear conductive or expedient for the protection or benefit of the corporation.

#### Article III

#### Capital Stock

The capital stock of the corporation shall consist of:

- a. <u>ONE HUNDRED</u> (100) shares of \$1.00 per value. For incorporation purposes, each share will have a nominal value set at <u>ONE DOLLAR</u> (\$1.00) per share as consideration.
- h. Said shares of common stock to have par value. All shares to be issued fully paid and non-assessable. The capital stock of this Corporation may be paid in lawful money of the United States or in property labor or services at a fair and just valuation to be fixed by the stockholders or by the board of Directors. Said determination of just value fixed by the Board of Directors is to be conclusive proof of said value.
- c. All of the common stock is to have one vote per share in the control of the management of the corporation.
- d. The holders of these shares of common stock are to have pre-emptive rights in the purchase of subsequent issues of stock.
