



The undersigned incorporator(s), for the purpose of forming a Profit Corporation under Charter 607 of the Florida Statutes, hereby adopt(s) the Following Articles of Incorporation.

ARTICLE I

The name of this corporation shall be: SERVICE MASTER COMPUTER, INC.

ARTICLE II

This corporation shall have perpetual existence and may engage in any activity of business permitted under the laws of the United States and of the State of Florida.

- A) The purpose for which this corporation is organized is to develop, assemble, import, export, lease, acquire, invest in, hold, use, install, handle, maintain, service, sell, distribute, trade and deal, as principal, agent or on commission, all computing software and electronic equipment and components and supplies.

- F) To acquire by purchase, subscription or otherwise and to receive, hold, own, guarantee, sell, assign, exchange, underwrite, transfer, mortgage, pledge or otherwise dispose of or deal in and the shares of the capital stock, or any voting trust certificates in respect of the shares of capital stock, scrip, warrants, rights, bonds, debentures, notes, trust receipts, and other securities, obligations, chose in action and evidence of indebtedness or interest created or issued by any corporation, join stock companies syndicates, associations, firms trusts, or persons, public or private, or by the government of the Unites States of America, or by any foreign government, or by any state, territory, province, municipality or other political subdivision or by any governmental agency, and as owner thereof to possess and exercise at the rights, powers and privileges of ownership, including the right to execute consents and vote thereon, and to do any all acts and things necessary and advisable for the preservation, protection, improvement and enhancement in value thereof.
