ARTICLE I - NAME AND ADDRESS

The name of this corporation is 202 TERRACE, INC. (the "Corporation"). The address of the principal office and the mailing address of the Corporation is 1666 Kennedy Causeway, Suite 505, North Bay Village, Florida 33141.

ARTICLE II - PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE III - CAPITAL STOCK

The aggregate number of shares which the Corporation shall have authority to issue is One Hundred (100) shares of common stock, all of which are to have a par value of Ten Dollars (\$10.00) per share. ARTICLE IX - INDEMNIFICATION


The Corporation shall indemnify any officer or director, or any former officer or director of the Corporation, to the fullest extent permitted by law.


