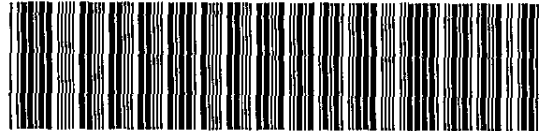

**ARTICLE I - NAME AND PRINCIPAL ADDRESS**

The name of the corporation is SundAmerica, Inc., and the principal address and principal place of business is 6860 Gulfport Blvd. S., #359, South Pasadena, Florida 33707.

**ARTICLE II - REGISTERED OFFICE AND AGENT**

The address of its registered office in the State of Florida is c/o STEVEN W. MOORE, P.A., 8200 Bryan Dairy Road, Suite 300, in the City of Largo, County of Pinellas, Florida 33777. The name of its registered agent at such address is Steven W. Moore.

**ARTICLE III - PURPOSE**
