

ARTICLES OF INCORPORATION
OF
CONSTRUCTION MANAGEMENT ASSISTANCE PROFESSIONALS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I
NAME

The name of this corporation shall be:

The Director may authorize and require the payment of the reasonable expenses incurred by the Director in attending meetings of the Directors. 
ARTICLE XI

This corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by the law.




