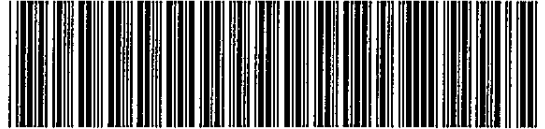




ARTICLES OF AMENDMENT


