ARTICLES OF INCORPORATION

The undersigned, desiring to form a corporation under and by virtue of the laws of the State of Florida providing for the formation, liability, rights, privileges and immunities of a corporation for profit, states as follows:

ARTICLE I Name and Address of Corporation

The name of this corporation shall be Sales By Owner Realty Inc., and the principal business and mailing address is 3914 Cassia Drive, Orlando, Florida 32828.

ARTICLE II Objects and Purposes of Corporation

The objects and purposes of the corporation and the general nature of the business or businesses to be transacted shall be:

- 1. To engage in any lawful businesses permitted or allowed under the Florida General Corporation Act.
- 2. To make and enter into all contracts necessary and proper for the conduct of its business or businesses.
- 3. To borrow money from any person, firm, or corporation; to issue bonds, debentures, or obligations of this corporation from time to time for any of the objects or purposes of the corporation; and to secure same by mortgage, pledge or by any other lawful means.
- 4. To have offices, conduct its business and promote its objects within or without the State of Florida, in other states, the District of Columbia, the territories and possessions of the United States, and in foreign countries without restriction as to place or amount.
- 5. To do any and all things necessary, suitable and proper for the accomplishment of any of its objects or for the exercise of any of the powers set forth above, whether herein specified or not, either alone or in connection with other firms, individuals, or corporations, whether in the State of Florida, or throughout the United States, or elsewhere, and to do any other act or acts, thing or things incidental or pertinent to or

connected with the businesses hereinbefore described, or any part or parts thereof, if not inconsistent with the laws of the State of Florida.

6. In general, this corporation shall have and exercise all the powers conferred by the laws of the State of Florida upon corporations for profit. It is hereby expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner such general powers.

ARTICLE III Term of Existence

The corporation shall have perpetual existence.

ARTICLE IV Designation of Registered Agent and Acceptance

The name of the initial registered agent of this corporation is Sylvester Jennings and the address of the initial registered office of this corporation shall be 3914 Cassia Drive, Orlando, Florida 32828.

The undersigned is familiar with, and accepts, the obligations attendant upon his appointment as registered agent of the corporation.

ARTICLE V Capital Stock

ARTICLE IX Identity of Incorporator; Pre-emptive Rights

The names and address of the incorporators are Sylvester Jennings, 712 tuten Trial Orlando, FL 32828 Edith M. Carr, 3914 Cassia Drive, Orlando, Florida 32828.

Every share holder of the corporation, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his prorate share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE X Annual Meeting of Shareholders

- 1. The annual meeting of the shareholders shall be held on the first Monday of January of each year, or at such other time as may be fixed by the By-Laws, at which time the Board of Directors shall be elected and such other business as my properly come before the meeting may be considered and transacted.
- 2. The officers of the corporation shall be elected annually by the Board of Directors at a meeting of the Board to be held annually following the annual Shareholders meeting.
- 3. The time, place and manner of calling meetings of the shareholders or directors shall be fixed by the By-Laws of the corporation.
