

## ARTICLES OF INCORPORATION for

ALLIANCE CARTING & EXCAVATION, INC.

### ARTICLE I. CORPORATE NAME AND PRINCIPAL OFFICE.

The name of this corporation is: Alliance Carting & Excavation, Inc.

### ARTICLE II. NATURE OF BUSINESS AND POWERS.

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

The person named as initial director shall hold office for the first year of existence of this Corporation or until his successor is elected or appointed and has qualified, whichever occurs first.



## ARTICLE IX. AMENDMENT.


