CORPORATE NAME, PRINCIPAL OFFICE
AND MAILING ADDRESS

The name of this Corporation shall be: **PUBLIC SEATING PROJECT, INC.**, with its principal office located at 508 Canal Street, New Smyrna Beach, Florida 32168 and its corporate mailing address being the same.

ARTICLE II
NATURE OF BUSINESS AND POWER

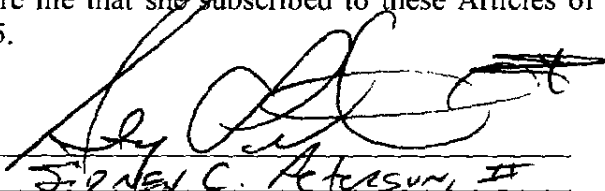

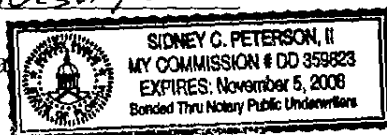

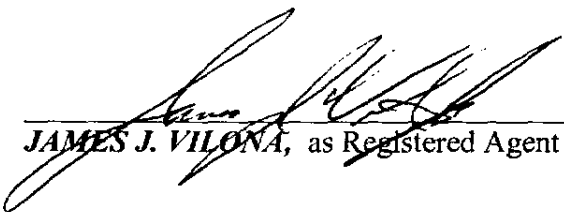
