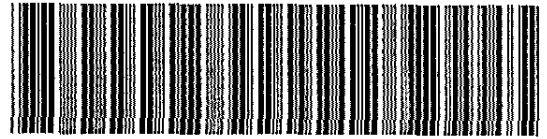



**ARTICLE 1**

The name of this corporation is Webbtech, Inc.

**ARTICLE 11**

The purpose or purposes for which this corporation is organized is for the purpose of transacting any and all lawful business.

**ARTICLE 111**
