OF

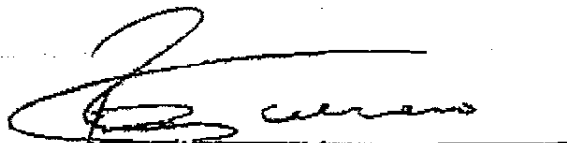
