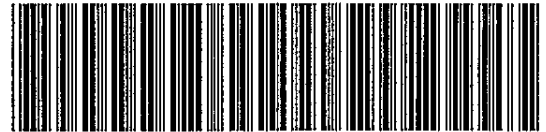

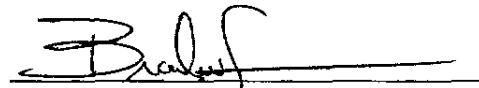

OF

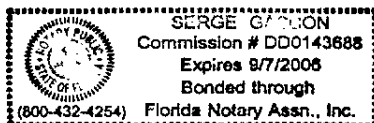
