TO
ARTICLES OF INCORPORATION

Article I of the Articles of Incorporation of STDC MANAGEMENT, INC.

hereby amended to read:

ARTICLE I

Name

The name of this corporation shall be: STDC MANAGEMENT, P.A.

Article III of the Articles of Incorporation of STDC MANAGEMENT, P.A. is

hereby amended to read:

ARTICLE III

Purpose

The general nature of the business to be transacted by this corporation shall be:

1. To engage in every phase and aspect of rendering to the public the same professional services a registered physician licensed under the laws of the State of Florida is authorized to render, but such professional services shall be rendered only through its officers and parties and agents who are duly licensed to practice medicine.

2. To invest the funds of the corporation in real estate, mortgages, stocks, bonds and other types of investments and to own real estate and personal property necessary for the rendering of such professional services.

3. To do everything necessary and proper for the accomplishment of any of the purposes or the attainment of the objects enumerated in these Articles of Incorporation or any amendment thereof, necessary or incidental to the protection and benefit of the corporation, and in general, either alone or in association with other corporations, firms or individuals, to carry on any lawful pursuit necessary or incidental to the furtherance of the purposes or objects of the corporation.

The paragraphs of this Article II shall be construed as both objects and purposes of

the corporation, and it is hereby expressly provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of this corporation otherwise permitted by law.

Article X of the Articles of Incorporation of STDC MANAGEMENT, P.A. is hereby amended to read:

ARTICLE X

Powers

This corporation shall have all of the corporate powers enumerated in the Florida "Professional Service Corporation and Limited Liability Company Act", and, in addition to and not in limitation thereof, this corporation shall have the power to guarantee the performances of obligations of other persons, partnerships, corporations, or other entities.

The Articles of Incorporation of STDC MANAGEMENT, P.A. is hereby amended to add Article III as follows:

ARTICLE XIII

Stockholder Restriction

Shares of this corporation's capital stock shall be issued only to individuals who are duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as those for which the corporation was incorporated. No stockholder of this corporation shall enter into a voting trust

agreement or any other type of agreement vesting in another person the authority to exercise the voting power of any or all of his stock.

In the event the ownership of shares of this corporation shall be transferred into the hands of others who are not qualified to own such shares under the provisions of the Professional Service Corporation Act, the members of the Board of Directors of this corporation shall have the power to fill any vacancy existing in the Board of Directors and all of the directors and all of the shareholders of the corporation shall have the power to amend these Articles of Incorporation so as to effect a change in the nature of business provided in Article II herein, so that this corporation shall have the power to conduct business in accordance with applicable law; except that this corporation shall not conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph, telephone or cemetery company, a building and loan association, fraternal benefit society, a mutual fire insurance association, cooperative association, state fair or exposition; provided, all of the directors and all of the shareholders sign a written statement manifesting their intention that the amendment of these Articles of Incorporation therein set forth be made, and the same written statement is filed in the office of the Secretary of State in accordance with applicable law.





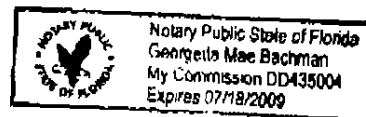
