In compliance with the requirements of chapter 607, Florida Statutes, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is University Center for Interventional Pain Management, Inc.

ARTICLE II

The existence of the Corporation shall begin on January 12, 2005, and shall be perpetual.

ARTICLE III

The street address of the principal office of the Corporation is 698 Brent Lane, Pensacola, Florida, 32503.

ARTICLE IV

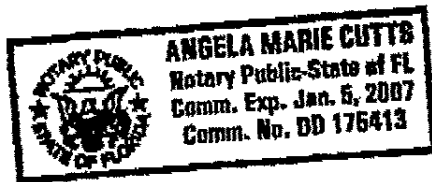
