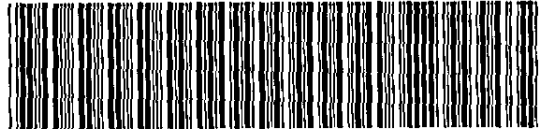

I (we) the undersigned, do to hereby associate ourselves
together and subscribe this Certificate of incorporation for the
purpose of forming a corporation under the laws of the State of
Florida, and subject to the following provisions:

*****ARTICLE ONE*****

The name of the of the corporation shall be:

The corporation may engage in any activity or business


