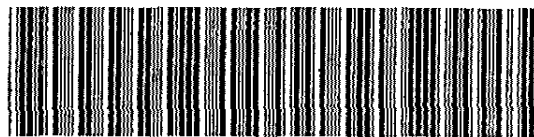

**ARTICLE I - NAME**

The name of this corporation is: **EL PICHINGUITA ONE DOLLAR PLUS, INC**

**ARTICLE II - DURATION**

This corporation shall have perpetual existence, unless sooner dissolved in accordance with the laws of the State of Florida.

**ARTICLE III - PURPOSE**

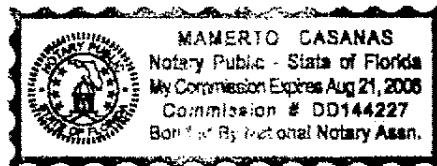
